IMPORTANT NOTES:

¹ Changes to parking assignments may be made only by a Declaration amendment recorded in the Bureau of Conveyances of the State of Hawaii as provided in Hawaii Revised Statutes Section 514B-40 and Section 3.4.3 of the Declaration. A copy of such amendment must be given to the Association. No trade, sale, conveyance or exchange of parking stalls is valid unless it is made strictly in accordance with these requirements.

² Due to construction and/or structural variations not all units of the same type are identical and the approximate net living and lanai areas may have slight variations.

³ In addition to the main lanai identified in this table, Unit Types E-L and E-R also have a covered entry lanai outside the front door containing approximately 39 square feet.

⁴ Common interest percentages were calculated based on the approximate proportion that a Unit's net interior area bears to the aggregate net interior area of all Units, with the results rounded and slight adjustments made so that the total equals 100%.

⁵ If one or more spatial units are created in the Project as provided in Declaration Section 17.7, the 0.001% common interest assigned to each such unit shall be deducted from the common interest assigned to Unit No. 76.
